Scores will be posted in the CMP Competitor Tracker system (<a href="http://ct.thecmp.org/app/v1/index.php">http://ct.thecmp.org/app/v1/index.php</a>) as the official results bulletin. As requested, the CMP provides certificates to persons who complete in club-sponsored matches.

**General Information:** Hearing and eye protection mandatory. Safety flag/ECI's (empty chamber indicator) required. Coaching is allowed for new participants (9.1.6) Entrants must be able to score targets or provide a substitute scorer. Slings permitted (and encouraged) except for standing position (6.9.7) Sling cuffs or padded slings may not be used.

Match participants required to provide their own rifle. Eligible rifles include M1 Garand, M1903 Springfield, M1 Carbine, other foreign vintage military rifles (Enfield, Mauser, etc.) "As issued" per CMP rules.

**Additional Information:** The affidavit is only required once by each club. Competitors under 18 must be accompanied by parent or legal guardian. Juniors also require a signed and completed *CMP PARENT CONSENT form on file with the match director*.
